The official languages of the conferences are English and Romanian.

All papers will include an abstract (max. 250 words) in English.

The full paper will be written in Romanian or English.

The abstract and the full paper will be sent as attached files (.doc) via e-mail at the address: simpozionbioterra@gmail.com

Maximum 2 papers will be accepted for each first author. Each paper will have maximum 6 pages and will be written according to the guidelines. The accepted papers will be published in extenso in the Symposium Proceedings volume (with ISBN) and in "Bulletin of Scientific Information" (ISSN 1454-816X) journal. Only those papers will be published that have a scientific content adequate to the Symposium theme and that fully respect the paper writing guidelines and the established deadlines.

PAPER WRITING GUIDELINES

Papers (tables and graphs included) should be written in Romanian or English, with a maximum number of 6 pages, in A-4 format.

Mandatory setting page, see Page Setup command, Paper window) framed as follows: top: 2.1 cm, bottom: 1.7 cm, inside: 3.0 cm, outside: 2.5 cm, gutter: 0, header: 2.0 cm, footer: 1.5 cm.

Papers must be written in Word, 1.0 spaced, font Times New Roman 12.

The paper will include:

Title - centered, caps lock, bold, font size 12;

Authors - centered, caps lock, bold, font size 11;

Institution to which the authors are affiliated will be specified under the title, being marked by a separate number for each institution; font size 11, bold, italic, centered. The number should be written before the institution (affiliation), using Superscript. For the first author or the corresponding author the e-mail address will be specified.

The abstract should be written in English (also for the papers written in Romanian): maximum 10 lines (250 words), left margin

(indented paragraph): 2.5 cm, justified, font size 10, italic.

Keywords - maximum 5 words, font size 12, italic, bold only the reference "Keywords".

The paper will be structured into the following parts, namely: Introduction, Materials and methods, Results and discussions, Conclusions, References.

Text – justified; first line: 1.27 cm, font Times New Roman 12.

Subtitles – caps lock, bold, centered, font Times New Roman 12.

Tables, pictures and graphs will be included in the text. Inside tables smaller font is allowed, in order to avoid Landscape oriented tables (all pages are required in Portrait).

References – in alphabetical order, as follows: authors (caps lock, bold), paper title, publisher or journal reference, page or number of pages. Font Times New Roman 12, hanging 1.27 cm, normal characters. References will be inserted in the text of the paper as in the model [n], where n represents the ordinal number of the source cited in "References".
