We specified that is the only university in the national private education, which

CHAPTER I

PRESENTATION OF THE HIGHER EDUCATION INSTITUTION "UNIVERSITY BIOTERRA OF BUCHAREST"

1.1. The judicial and organization background

The BIOTERRA University is a high education institution relatively young, at the beginning being a constituent part of the University BIOTERRA University foundation of Bucharest which was initiated by some remarkable personalities of the didactic and scientific domain in the applied bioengineering, economic engineering, rural tourism, alimentary industry and phyto-sanitary and zoo-veterinary control of the goods, law and legislation. Field the statute and structure of the BIOTERRA University Foundation were certified according to the legal procedures by the **Civil Decision no. 88 from the 19th May 1994** of the District 1 Low Court, file 96/P.J/1994. With the implementations and development of the organization and accreditation of the specializations in the high educations system coordinated the N.C.A.E.A., the specializations existing in the BIOTERRA University Bucharest were authorized to function temporary by the H.G. nr. 294/1997 and in Official Gazette of Romania part first, 130/25.06.1997 and in every other government decisions issued till 2002.

In 2002, after achieving all the accreditation levels, the **BIOTERRA University** in Bucharest was **accredited by the 480/2002 law**, published in

Romania Official Gazette no.512 from the 17th July 2002. According to the first decision of this law, ***BIOTERRA University of Bucharest is a high education institution, juridical person of private law and public utility, part of the national education system***, with the residence in Bucharest nr .81 Garlei Street district 1.

1.2. The name and residence of education supplier

In the BIOTERRA University structure there are included according to the regulations of the establishment and ***G.D. nr 635/2008***, published in Official Gazette of Romania first part no.834/11 December 2008, the following accredited faculties:

- ***Faculty of Agro-Tourism Management*** accredited in 2002 at the same time with the promulgation of the 480/2002 law with the specialization ***Engineering and Management in Public Alimentation and Agro-tourism*** in the license field ***Engineering and Management*** having 4 years of study daily frequency and reduced frequency, with 240 credits.

- ***Engineering of Alimentary Products Faculty*** accredited in 2005 by the N.C.A.E.A. with the specialization of ***Engineering of Alimentary Products*** heaving also 4 years of study with 240 credits daily and reduced frequency courses.

- ***Control and Expertise of Alimentary Products*** accredited in 2005 by the N.C.A.E.A with the specialization the ***Control and Expertise of Alimentary Products*** in the field ***Engineering if Alimentary Products***, heaving 4 years of study-daily and part-time frequency courses, 240 credits, too.

- ***The Faculty of Law*** accredited in 2005 by the N.C.A.E.A in the field of law, heaving 4 years of study, daily and reduced frequency courses – 240 credits.

The BIOTERRA University in Bucharest has also the following authorized faculties and specialties:

- ***Faculty of Agro -tourism Management in Focsani***, Vrancea county, with the specialization ***Engineering and Management Alimentation and Agro-Tourism***;
- ***Faculty of Agro -tourism Management in Alexandria***, Teleorman county, with the specialization ***Engineering and Management in Public Alimentation and Agro-Tourism***;
- ***Faculty of Agro -tourism Management in Slobozia***, Ialomita county, with specialization in ***Engineering and Management in Public Alimentation and Agro – Tourism***;
- ***Faculty of Control and Expertise of Alimentary Products in Alexandria***, Teleorman county, with the specialization ***Control and Expertise of Alimentary Products***;
- ***Faculty of Control and Expertise of Alimentary Products in Slobozia***, Ialomita County, with the specialization ***Control and Expertise of Alimentary Products***.

The specializations presented, came out during the years, starting with the authorization to the accreditation in the Government Decrees which established these aspects of which we can reveal G.D. 535/1999; G.D. 379/2000; G.D. 916/2005; G.D.

676/2007; G.D. 635/2008.

Referring to the specializations that function in the structure of the faculties of the BIOTERRA University of Bucharest – we must emphasize that this university was the initiator of two unique specializations: *Engineering and Management in Public Alimentation and Agro – Tourism and Control and Expertise of Alimentary Products*; specializations that were recognized immediately even from the beginning by the number of enrolled students, as well as a series of faculties in some universities (UASVM Bucharest – Cluj) authorized to develop some license studies at these two specializations initiated by the BIOTERRA University of Bucharest.

1.3. Mission and strategy objectives

During the development of the activity, the BIOTERRA University succeeded to create its own personality, and a strong position in the field of the Romanian high education, in the modern study curricula as well as the education spaces, but especially with the didactic staff which lead and organize the didactic and research activity.

The didactic and research mission of the university is meant to train specialists with complex profile who can use efficiently and ecologically the natural, environment, financial and human resources, in the specific tradition of the Romania people, with the integration of the agro-alimentary, touristic and judicial values in an unitary conception of all the elements which lead to the achievement of some valuable performances in the European Community, as well as in the internal and international level.

The scientific research missions consists in the organization and development of the applied and fundamental scientific research, with concrete result in consulting scientific works, expert examinations, publications, as well as during the internal and international meetings, congresses, symposiums, round table meetings.

The curricula follow the promotion of the structure specializations as well as of other new specialization demanded on the market, as there were promoted the specializations of Engineering and Agro -tourism Management and Control and Expertise of Alimentary Products, which when they were initiated, they were the only ones in the Romanian high education system field.

With its own structures it is meant to achieve a superior quality of the education process and of the research works, making evident the beneficent parts, stimulating and regenerating specific to the high education system.

The University aims to keep and develop endlessly the professional and scientific research potential it has, to grow the consolidation of the specialization it offers nowadays, as well as initialing new specialties inside the institution.

Using always the valuable experience of the Romanian education system, and keeping in mind the integration of Romania in the European Union, the curricula are always made up to date, with a genuine scientific and cultural load, such as after following the study years, our graduates, can be able to face the competitive system of the market economy.

The mission of the BIOTERRA University of Bucharest is to create and develop an

area of study and scientific research for the students, didactic staff and research workers national and international standards.

- The main mission on long, medium and short term of **Faculty of Agro-tourism Management** with the specialization **Engineering and Management in Alimentation and Agro-Tourism** is contribute to immediately and efficiently at the diminutions of superior staff with high specialization in the engineering and management field, able to use in an efficient way the natural, financial, human resources with the purpose of the development of the public alimentation and agro-tourism network, modern and efficient, which can perform an activity as a result of a high level management in this field.

With the subjects existing in the teaching plans as well as the specialty practical period the students perform we aim to evaluate the touristic and Agro-tourism resources of the regions of own country.

- The main mission of **Faculty Engineering of Alimentary Products** with **Engineering of Alimentary Products** specialization is training engineers with high specialization in processing and reevaluation of the alimentary products, of the technologies in the alimentary industry, which can integrate immediately in the activity of actual a future commercial societies in this field, able to perform in production the demands imposed by the integration of Romania in the European Union.

The subjects referring to obtaining „The Ecological Product” are prior in the teaching plans, taking into account the big potential an own country has in this field, as well as the demands on the E.U. market.

- **Faculty of Control and Expertise of Alimentary Products** with the specialization **Control and Expertise of Alimentary Products** the first specialization accredited with this profile of the Romanian University education, has as a strategy aim the training of specialists with high level professional qualification to ensure in the commercial societies of profile the technology process from the production, depositing to delivery and valuation, with the purpose to ensure the alimentary security and protection of consumers, including preventing the alimentary bioterrorism.

- **Fculty of Consumer protection and environmental**, Bucharest, auhorised in 2012

A second specialization prepares experts to provide an environment for living and working with people healthy, vigorous and apply scientifically and operating the most effective methods for environmental and consumer protection.

It forms highly qualified specialists who will work in the field of consumer protection and environmental protection, able to effectively use human and natural resources, in order to develop this sector, it also adapting to the european requirements and standards.

Graduates of this specialization will work in the veterinary field, public health, environmental and consumer protection, etc.

These qualifications are imposed on the labor market of current development trends in the food industry, food safety and security. Mention that the labor market is a massive demand for specialists in this area, because until now there was not such a specialization.

- The main mission of **Faculty of Law** with **Law** – specialization is to ensure the training of high level specialists in the judicial system, who knows very well the

Romanian, European Law, the especially doctrine and jurisprudence.

The Law Faculty mission consist also we training the students as good specialists in the Romanian society, to be constantly guided by the justice spirit, honesty and integrity, the knowledge and observance of the actual legislation central and local administration, in the public and private institutions with judicial personality, such as to ensure the juridical substance necessary in the action of law. Faculty mission is so specialized training of students and the cultural development of their science.

Faculty of Law by specialization in the “Law”, in order to fulfill its mission, aims redoubtable preparation of specialists in this field. Faculty has the mission specialist training of students and the cultural development of their science, each program of study based on the correspondence between school and university qualifications followed.

Under the *strategic plan*, elaborated for the period 2011-2014, the BIOTERRA University of Bucharest proposed to provide the following priority objectives:

- aligning at the national and international standards on parameters to assess internal and international content and quality of curricula;
- establishment of a single professional competence criteria in assessment and promotion body, selection area and academic personnel, technical-administrative and economic;
- improvement of inter-university doctoral training, internships and graduate studies in the country and abroad;
- participation in research programmes on domestic and international, on the basis of contracts, in accordance with the legislation in force and the standards laid down by Romania Ministry of Education;
- educating students in the spirit of knowledge, maintaining and development of national heritage, as well as protection of the environment;
- realization of mutual exchanges of teachers and students with similar institutions of higher education in the country and abroad, in order to improve the students, didactic and modernization;
- promote participatory democracy and pluralism of opinions among teachers and students;
- socio-economic protection of members of the academic community by ensuring optimal conditions for affirmation and for promoting activities with students;
- the development and modernization of the base material and didactic-scientific one, through the development and implementation of the plan of investments set forth on a medium and perspective;
- diversification of sources of financial income from collaborations and research activities;
- improving institutional capacity through continuous implementation of a quality management system to be able to ensure the integration of education and research in the European Higher Education Space.

The mission and objectives assumed customize BIOTERRA University under the system of national and european space of higher education strategic plan for the period 2011-2015, highlighting this fact.

1.4. University Charter and its regulations

The BIOTERRA University of Bucharest, is the only private accredited University in Romania, which has faculties and specializations in the agro-food domain, this fact is in full harmony with the mission and strategic objectives which it promotes.

The BIOTERRA University is unfolding activity by law no.480/2002 establishing under Law No.84/1995 of education with any future changes, law 288/2004 concerning the organisation of University studies with any future changes, the status of teachers and Law no.480/2006. In the above mentioned by laws have been drafted: *University Charter* which comply with the regulations in force, *its inner rules of procedure and the regulation on the work of students*, which constitute the basic documents of the activities carried out within the framework of Bioterra University of Bucharest.

1.5. University management and administration, managerial structure

In the spirit of the mission and objectives assumed, the BIOTERRA University has a coherent system of management, transparent and integrated in order to achieve an effective and efficient administration, corresponding to a performance management.

Institutional structure of the University is established by the law establishing the No. 480/2002 and its regulations, conferred by the University's autonomy.

The BIOTERRA University the organizational structure of the academic sector is presented in the organizational structure of the university, with his own personal incadrata election result, which corresponds to the point of view of professional qualification, the terms and conditions required for the occupation of posts provided. T

he BIOTERRA University Senate represents the least formatiunea high academic and leadership activities was elected in 2008, according to the regulations of the Charter of the University and the "*Methodology of organization and unfolding of the election of the management organs*" of the BIOTERRA University.

Following the elections of 2008, the BIOTERRA University Senate 33 members are part of the 8 students, its component in the 2008-2009.

Rector of the BIOTERRA University, was elected in January 2008 and confirmed in Office by order of the Ministry of Education, Research Youth and Sport no. 3160/25.02.2008.

In the BIOTERRA University legal provisions have been complied with for choosing the collective management bodies (Faculty Council and Senate) as well as leading professionals. The staff at Bioterra (Rector, Vice-Rector, Dean, Associate Dean, as well as the heads of the Chair) shall be composed of educators titularizate generalization of the rule, with the institution, are professors or associate professors, owners and not in terms of appointment of the station.

Student representatives are part of the BIOTERRA University Senate 8 in number (i.e. 25%), were elected democratically, and making proposals on nominees through

voting by the League of students, and at the level of the faculties, the Faculty and students belong. The procedure for election of all members of the BIOTERRA University Senate., including student democratic and transparent, is non-discriminatory and do not limit the right of students to represent and to be represented.

Students take cognisance of all decisions of the BIOTERRA University Senate by participating in the sessions of its direct, to which they are admitted and students wishing to do so but are not elected members. Informing students and is accomplished by other means, such as: means of displaying the notice boards of the University, published on the website of BIOTERRA University of the main decisions of the Senate, information of teaching staff responsible for the information of the studies and the Dean.

Pedagogical staff carries out the activity according to the will of States prepared by the departments functions of the vUniversity of Bucharest.

The library has personnel with higher education for librarianship.

1.6. The material basis of the university

The BIOTERRA University of Bucharest, has developed continuously and in a dynamic fast construction of own spaces allocated to teaching process (lecture halls, laboratories, seminar rooms) as well as in their facilities to the required standards for the promotion of a high quality higher education.

The BIOTERRA University in establishing has ordered its own heritage associate Art. 5 of the Act 480/2002, the value on the date that the 46.949 3 million lei, real estate, movable, imobilizari and financial assets.

In the period 2002-2008, The BIOTERRA University heritage of impetuous developments by building and buying new spaces devoted to the didactic.

Development of material basis was carried out in accordance with its mission and strategic objectives of the BIOTERRA university, watching is providing education and research spaces corresponding to specific curricula, teaching halls (course or seminar), teaching and research laboratories, research and practice centers, student dormitories and other social amenities in accordance with the rules of safety and sanitary toilet in forcerespecting the differences between forms of extra-mural education day and the objectives of the research activity.

Their quality is settled depending on the surface, volume, technical condition, the number of students and teaching personnel and research, education programs on the differentiated mandates and institutional level by reference to the rules in force. The development of this database pursues and materials in anticipation of a realistic policy, on the basis of investment revenue forecast in the budget of income and expenditure the halls devoted to teaching process have equipment technical learning, teaching and communication that facilitates the work of teaching staff, and increases the degree of receptivity and interest of students.

Teaching and research laboratories with equipment and means of functioning of

existing dotarilor in proper universities developed, in the EU the BIOTERRA University of has soft corresponding subjects of study, with licenses for use, according to the bills.

University management provide courses and other artworks multiplication required education process, developed by teachers and students to put them into a corresponding number.

Currently, the University has owned all Bioterra offers education, with all necessary facilities. Education spaces, buildings and land way University Bioterra of Bucharest have been assessed through a recent evaluation report on 31.12.2008 by firm "PRECISS Consulting SRL", and the results were made public in April 2009.

1.7. Financial activities

The BIOTERRA University has its own sources of funding, insufficient short-term (yearly) and with a view (for the next several years) that you provide through the budget of income and expenses for carrying out the mission, as appropriate, and targets, with a realistic financial policy regarding the development of base materials and investment (financial strategy and development of the material basis of the BIOTERRA University). Budget of income and expenditure is approved by the BIOTERRA University Senate, its regulations being met during the financial year for which it was drawn up.

The BIOTERRA University as a legal person governed by private law and public utility is registered by the tax code and has in the bank account, which is carrying out financial activities.

Financial activity is evidenced by documentation specifying the associated accounting system, according to the legislation in force. In the main income is derived from the fees, the amount of which shall be in accordance with the average costs per academic year tuition.

The amount of fees tuition is approved by the BIOTERRA University Senate and is brought to the knowledge of students through various means of communication. Financial expenses mainly consist of the costs of investments and the necessary development of didactic dotarilor, as well as from the costs realized by scolarizarea auxiliary teaching staff involved in teaching activities. By establishing the law itself, the BIOTERRA University has a non-profit.

The BIOTERRA University grant with unalterable material support through its own budget allocation from students, consisting in:

- tuition fee reduction by 10% for students who pay the full tuition fee until 15 October of the academic year;
- reduction of 25% of the tuition fee for one of the students follows the courses of the curricula of University-brothers, sisters, husband and wife, parents and children;
- awarding grants social consisting of a partial or total exemption from payment of tuition fees for students with special family situation;
- granting of merit scholarships that consist of a partial or total exemption from payment of tuition fee for special students with professional activity (average graduation

year over 9,50 and this good at teaching activities).

1.8. The students

Regarding the recruitment and admission of students in first year of study, the BIOTERRA University apply a policy of transparency brought to the knowledge of candidates with at least 6 months prior to admission, by popularizing curricula, admission requirements, tax benefits, which are awarded to students and the level of tuition fees.

Admission is based solely on knowledge and core competencies of the candidate's own skills and does not apply any kind of discriminatory criteria.

Applying the regulations in force, admission to the BIOTERRA University will only be possible on the basis of diploma of baccalaureate or other equivalent studies acts recognized by Romania Ministry of Education.

Admission is based on a methodology developed by its own admission, in accordance with the legislation in force, namely the order of the Romania Ministry of Education issued to this effect.

Completion of the cycle, the license is accomplished according to legislation currently in existence, namely the order of the Romania Ministry of Education and Research no.295/05.02.2007 and the *Methodology support examinations for completion of the studies* prepared in accordance with the above mentioned order.

After examination of licence completes order forms of the diplomas, purchased by Romania Ministry of Education.

1.9.The library

The BIOTERRA University Library is in a modern space, equipped with lecture halls and book store. To serve this compartment are engaged two frames with training courses and university librarian.

Bioterra University Library is equipped with four lecture halls with a total of over 400 seats and fund his own book (3196 book titles, with 20.547 volumes), 42 for the subscriptions, with 5 on average every subscription to regular publications and Romanian and foreign, according to the disciplines stipulated in the education plans, according to the bills.

The BIOTERRA University to come in support of students, buy books, and through the dissemination to the disposition thereof without charge fee for sale. Of all the bibliographic material, a sufficient number of copies are retained for the book of the library.
